General Competition Information

1. Organizers:

SWIM-TEAM TuS 1859 Hamm e.V.

Rietzgartenstraße 46
D - 59065 Hamm / Germany

2. Regulations:

The competition will be held in accordance with the competition regulations of the DBS as an international competition. The classification regulations (KO), the competition regulations (WO), the legal regulations (RO) and the anti-doping regulations (ADB) of the DBS and the Para Swimming Division apply in the current version. These regulations are analogous to the DSV competition regulations and the WPS Swimming Rules. By submitting their entries, the clubs and participants accept these regulations.

The 7th Open International Stadtwerke Cup is organized for athletes with physical, visual, intellectual and other impairments as well as athletes without impairments.

Doping is prohibited in accordance with the regulations of the German Disabled Sports Federation (DBS-NPC). The DBS Anti-Doping Code and the regulations of WADA, NADA and, in the case of international events, the anti-doping regulations of the relevant international sports federation (collectively: anti-doping regulations) apply. By submitting the entry form for the event, the participant accepts the anti-doping regulations in their current version (available at www.dbs-npc.de). Doping tests may be carried out on a random basis. By submitting the entry form for the event, the participant acknowledges that NADA is responsible for the results management procedure and the disciplinary procedure in accordance with the NADA Code and that the German Court of Arbitration for Sport at the German Institution of Arbitration in Cologne is responsible for the first-instance proceedings, including interim relief, in accordance with the DIS Sports Arbitration Rules, excluding recourse to the ordinary courts of law. Each participant is responsible for checking the doping relevance according to the current WADA Prohibited List in the case of therapeutically necessary intake of medication and/or therapeutically necessary use of methods. The following must be observed:

- For athletes in the NADA test pool (ATP, NTP or RTP): the use of prohibited but therapeutically necessary drugs and/or methods must be proven by a valid medical exemption (TUE).
- For athletes without test pool membership, the following applies: after a doping control and following a request by NADA, a retroactive Therapeutic Use Exemption (TUE) must be applied for. No application can be made in advance. As soon as additional steps need to be taken by the athletes concerned, NADA will contact them immediately and provide comprehensive information.

Further information on the TUE procedure can be found at <https://www.nada.de/medizin/aktuelle-medizinische-hinweise> and at www.dbs-npc.de (under Anti-Doping). In case of doubt, please contact the responsible DBS sports physician or the DBS Anti-Doping Department.

3. Location of competition:

The venue is the adventure spa "MAXIMARE" in east of Hamm, Jürgen-Graef-Allee 2, 59065 Hamm.

The competition pool is 50 m long, 8 lanes are separated by wave killer lines.

The water temperature is about 27 ° C.

It is carried out electronic timing (Colorado Time Systems).

The start takes place after the one - start - rule.

4. Start authorization:

Eligible to compete are all members of clubs and starting groups in the DBS and its affiliated professional associations who are fit for the sport and have the appropriate registration and valid classification (according to the DBS database, swimming department at www.abteilung-schwimmen.de). Foreign clubs are eligible to compete if their association is affiliated to the WPS or World Aquatics. All DSV clubs are eligible to participate, provided they are in possession of the association rights and their swimmers are registered in the DSV license register and have a valid annual license.

Athletes born 2014-2016 may start a maximum of 6 times per day (youth protection). Incoming entries that do not comply with this paragraph will be automatically canceled. The entry fee remains with the organizer. All performances will be included in the database/best list of the DSV, DBS and/or WPS with a valid license number.

5. Start classes:

Start classes according to the classification rules of the Para Swimming Division of the DBS.

People with physical disabilities in the start classes:

- S1 to S10 Freestyle/Backstroke/Butterfly swimming
- SB 1 to SB 9 Breaststroke
- SM 1 to SM 10 Medley swimming

People with visual impairments in the starting classes S11 to S13

People with intellectual disabilities in starting class S14

People with general disabilities in start class AB

People without disabilities in starting class NB

6. Classification:

There will be no classification on the day of the competition. The classification data will be taken from the database of the DBS swimming department (see www.abteilung-schwimmen.de). For foreign clubs, the classification for WPS registered athletes will be taken from the WPS classification database. Athletes with a national classification in their home country must enclose the relevant documents with their entry which prove the classification including exceptions.

7. Sport Health:

The athletes themselves are responsible for ensuring that they meet the health requirements for training and competition. To determine fitness for sport and competition, the DBS expressly recommends that a sports medical examination be carried out at least once a year.

8. Medical Assistance / Medical Service:

Medical Assistance / medical service is on site!

9. Scoring:

The scoring takes place according to the current DBS-1000-points table (see www.abteilung-schwimmen.de, category regulations). Female athletes and male athletes counted separately.

All athletes will be judged together in the following age groups:

Open class: age group without age limit

Youth A: age groups 2007 - 2008

Youth B: age groups 2009 - 2010

Youth C: age groups 2011 - 2012

Youth D: Years 2013 - 2014

Youth E: Years 2015 - 2016

10. Awards:

The 1-3 places each junior class and the open class will receive medals.

All athletes receive a global certificate with all swum routes.

This certificate will be made available for download.

11. Victory Ceremony:

The victory ceremony is a part of the swim competition. They are carried out during the event and to announce in time. The organizer reserves the right to lack of time to carry out only selected victory ceremonies. Medals will not be forwarded.

12. Registration:

Entries must be made electronically in DSV7 or Lenex format. Please ensure that all IDs and start classes/exceptions are entered. Alternatively, entries can be made on the attached entry form/list or DSV entry form/list. The entry form must be signed personally if you only enter via the entry form/list. Entries will be considered in the order in which they are received.

Deadline for registration is Tuesday, November 13th, 2024 at 12 pm incoming post box / mailbox.

After receipt of the entries, each club will receive a confirmation of entry with the number of entries received for checking purposes. Complaints must be reported immediately.

13. Entry fee:

The entry fee for individual starts is € 6.00 per start and for relays € 12.00 per relay team. For each individual start over 800m/1500m freestyle € 7,50. The entry fee per team is to be transferred to the following account:

If the event is canceled due to force majeure, the registering club is not entitled to a refund or compensation for other damages, such as travel and hotel costs!

14. Registration Restriction:

The organizer reserves the right to refuse further club entries from 3000 entries. Entries will be considered as they are received.

The following standard times are set for all age/starting categories - if the times are exceeded, the referee will end the competition for the athlete.

- 1500m freestyle - target time 30:00.00 min
- 800m freestyle - target time 20:00.00 min
- 400m freestyle - target time 10:00.00 min
- 400m medley - target time 10:00.00 min
- A target time of 05:00.00 min applies for all 200m distances.

For competitions 1, 2, 19, 20, 35 and 36, an entry list/entry result will be drawn up. The fastest athletes will start. The heats are then seeded and an entry result for these competitions is posted in the swim hall. Cancellations must be made by the judges' meeting of the respective section!

15. Panel of judges:

Each Club/Team with more than 10 entries, please report a judges with application request and qualifying each section. For more than 30 entries you have to provide two, for more than 50 entries three judges.

16. Oppositions:

Oppositions must be submitted to the referee in writing and with a deposit of € 50.00 (DBS) within 30 minutes of the announcement of the minutes (posting).
Oppositions against decisions fact are not allowed.

17. Valuables:

The organizer accepts no liability for theft, accidents or damage of any kind.

18. Entry list:

The entry lists will be available for download no later than one week before the start of the competition. The protocol will be available for download on the homepage immediately after the end of the competition.
